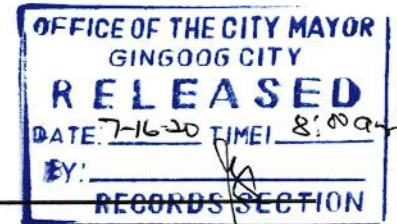

**EXECUTIVE ORDER NO. 43**  
**Series of 2020.**

**AN ORDER EXTENDING THE DECLARATION OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN THE ENTIRE CITY OF GINGOOG EFFECTIVE JULY 16, 2020 UP TO JULY 31, 2020 PURSUANT TO THE RECOMMENDATION OF THE INTER-AGENCY TASK FORCE.**

**WHEREAS**, the President has placed the entire country under the State of Public Health Emergency due to the alarming threats posed by the Corona Virus Disease (COVID-19) through Proclamation No. 922;

**WHEREAS**, on March 16, 2020, President Rodrigo R. Duterte has declared a State of Calamity throughout the Philippines due to Coronavirus disease through Proclamation No. 929;

**WHEREAS**, on May 29, 2020, by virtue of Executive Order No. 34, series of 2020, the entire City of Gingoog was placed under Modified General Community Quarantine effective June 1, 2020, up to June 15, 2020 and was extended up to July 15, 2020 by virtue of Executive Order Nos. 39 and 42, all series of 2020;

**WHEREAS**, as of July 15, 2020, there are already 58,850 confirmed cases of COVID-19 in the country and there are 1,614 fatalities reported by the DOH and the number of confirmed cases continue to surge;

**WHEREAS**, as of July 15, 2020, the City of Gingoog has recorded six confirmed cases of COVID-19 with one (1) recovery and all of them are Locally Stranded Individuals (LSI) and OFW. They are now under treatment and strict monitoring at the City Isolation Unit (CIU) in Barangay Pangasihan, Gingoog City;

**WHEREAS**, based on the latest recommendation of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID) the province of Misamis Oriental is considered to be a low-risk area and as such, it shall continue to be under Modified General Community Quarantine beginning 16 July 2020 up to 31 July 2020;

**WHEREAS**, with this new recommendation from the IATF, it is imperative upon the city government to extend further the declaration of a Modified General Community Quarantine in the entire City of Gingoog.




NOW, THEREFORE, I ERICK G. CAÑOSA, by the virtue of the power vested in me by law as City Mayor of Gingoog, do hereby issue this Executive Order and declare the following:

**Section 1: DECLARATION.** It is hereby ordered to extend the effectivity of Executive Order No. 34 series of 2020 as amended declaring a Modified General Community Quarantine in the entire City of Gingoog beginning July 16, 2020 up to July 31, 2020. With this declaration, everyone is reminded to follow the protocols on the mandatory wearing of facemasks, frequent hand washing, and strict observance of social distancing at all times.

**Section 2. POLICIES AND GUIDELINES GOVERNING THE MODIFIED GENERAL COMMUNITY QUARANTINE.** The existing provisions in the Omnibus Guidelines on the Implementation of Community Quarantine issued and released by the Inter-Agency Task Force (IATF) as well as IATF issuances relating to the implementation of MGCQ for low-risk areas shall still be strictly implemented in the city.

**Section 3. PROVISIONS ON CURFEW, LIQUOR BAN, QUARANTINE CHECK-POINTS, AND WEARING OF FACEMASKS.**

- a. The city-wide curfew hour for adults is set from 10 pm to 4 am and the new curfew hours for minors are from 6pm to 5am.
  - b. Selling and possession of liquor and other alcoholic/intoxicating beverages shall be allowed from 5am to 6pm only. However, drinking and consumption of liquor and other alcoholic/intoxicating beverages shall be prohibited at all times outside residences and in all public places including KTV bars, resto-bars, restaurants, and other similar establishments *as amended by Executive Order No. 37 series of 2020* shall also be in full force and effect until further notice;
  - c. The established quarantine check-points located in Barangays San Luis, Pangasihan, and Kahulogan, Brgy. 26 manned by the members of the COVID-19 Task Force and the PNP shall continue its operation. The Travel requirements set forth by the DILG and the IATF shall be implemented at the said check-points, if applicable, *as amended by Executive Order No. 37 series of 2020*;
  - d. The order mandating every person within the territorial jurisdiction of Gingoog City to wear facemask at all times when going out of their residences, at the workplace, entering government offices and while in public places under Executive

Order No. 25 series of 2020 shall continue to be in full force and effect until the State of Public Health Emergency shall be lifted or withdrawn by the President or by other higher authorities. The mandatory wearing of facemask is also provided under City Ordinance No. 2020-353 as amended;

**Section 4. OPERATION OF PAHAYAHAY SA PANTALAN AND RIZAL PARK.** The Pahayahay sa Pantalan and the Rizal Park shall still be open to the public from 5am up to 8pm to allow the conduct of all physical fitness and other activities in the area but subject to strict compliance of the minimum health standards set by the IATF and previous Executive Orders.

**Section 5. MISCELLANEOUS.**

- a. All other issuances or resolutions that have been issued or to be issued by the IATF with regards to the implementation of the Modified General Community Quarantine for low risk-areas are also deemed adopted and shall also be made an integral part of this Order;
- b. The provisions of Executive Order No. 35, 37, 39, and 42, all series of 2020 on the additional guidelines in the implementation of MGCQ in the City which are consistent with this order shall be adopted;
- c. Provisions of Executive Order Nos. 20, 21, 23, and 25, all series of 2020, as well as the provisions of City Government of Gingoog Guidelines numbers 1 to 5 for the prevention of coronavirus disease (COVID-19) which are not in conflict with this Order, are hereby adopted and shall form an integral part hereof.



**Section 6: PENALTY CLAUSE:** Any violations hereof shall be dealt with under existing laws and ordinances.

**Section 7: REPEALING CLAUSE:** Any Executive Order not consistent with this Order is hereby amended or repealed.

**Section 8: SEPARABILITY CLAUSE:** In case any provision of this Order shall be declared invalid, illegal or unenforceable by higher authorities or by the Courts, the validity, legality, and enforceability of the remaining provisions shall not in any way be affected or impaired.



**Section 9: EFFECTIVITY:** This Executive Order shall take effect on the date and time abovementioned.
