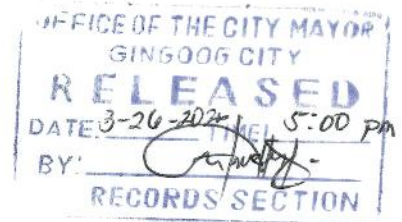

EXECUTIVE ORDER NO. 23
Series of 2020.

AN ORDER IMPOSING A 12-HOUR CURFEW FOR ALL MINORS IN THE ENTIRE CITY OF GINGOOG FROM 5PM TO 5AM EFFECTIVE TWELVE MIDNIGHT OF MARCH 27, 2020 UP TO APRIL 14, 2020.

WHEREAS, the President has placed the entire country under the State of Public Health Emergency due to the alarming threats posed by the Corona Virus Disease (COVID-19) through Proclamation No. 922

WHEREAS, on March 16, 2020, President Rodrigo R. Duterte has declared a State of Calamity throughout the Philippines due to Corona virus disease through Proclamation No. 929;

WHEREAS, the entire province of Misamis Oriental is also placed under the State of Calamity due to Corona Virus Disease 2019 (COVID-19) pursuant to Sangguniang Panlalawigan Resolution No. 344-2020; and the City of Gingoog has adopted the said Resolution declaring the entire City under the State of Calamity through SP Resolution No. 2020-101;

WHEREAS, effective twelve noon of March 21, 2020, the entire City of Gingoog was placed under a General Community Quarantine up to April 14, 2020 through Executive Order No. 21 series of 2020.

WHEREAS, on March 24, 2020, the Office of the Provincial Governor has declared a General Community Quarantine in the Province of Misamis Oriental for the period of March 24, 2020 to April 14, 2020;

WHEREAS, as of March 25, 2020, there are 5 confirmed cases of corona virus disease (COVID-19) in Region 10 and 242 Persons Under Investigation (PUIs) according to DOH-Northern Mindanao;

WHEREAS, the minors are among the most vulnerable sector of the society and it is imperative upon the local government to protect the physical well-being of its youth specially the minors by effecting measures which will safeguard their health and safety;

WHEREAS, the City has an existing Ordinance setting Curfew hours for minors under City Ordinance No. 2016-290, however, considering that the entire country is under the state of public health emergency and the city is under the State of Calamity, there is a need to declare a 12-hour curfew for all minors from 5pm to 5am in order to limit their movement during these hours to protect their health and in order to prevent the spread of the virus.

NOW THEREFORE, I ERICK G. CAÑOSA, by the virtue of the power vested in me by law as City Mayor of Gingoog, do hereby issue this Executive Order and declare the following:

Section 1: Declaration: There shall be a 12-hour curfew for all minors in the entire City of Gingoog from 5pm to 5am effective twelve midnight of March 27, 2020 up to April 14, 2020 unless extended or shortened upon the recommendation of the Gingoog City Covid-19 Task Force. Minors maybe allowed to go out of their houses during curfew hours for any medical emergencies or other humanitarian reasons provided he/she is accompanied by an adult family member or a relative within the fourth civil degree and they must bring with them a valid ID. The city-wide curfew hours from 8pm to 4am provided under Executive Order No. 20 series of 2020 is still in effect for those of legal age.


Section 2: Implementation: This order shall be strictly implemented by the City Social Welfare and Development Office together with the Barangay Captains and their officials and the members of the Gingoog City Police Station. The parents or guardians of these minors are enjoined to ensure that their children or ward stay at home during curfew hours.

Section 3: Penalty Clause: Any violations hereof shall be dealt with under existing laws and ordinances.

Section 4: Repealing Clause: Any order or issuances not consistent herewith is hereby amended or repealed.

Section 5: Effectivity: This Executive Order shall take effect on the date and time abovementioned.
